JDS readers represent education, industry, and government agencies in more than 70 countries with interests in biochemistry, breeding, economics, engineering, environment, food science, genetics, microbiology, nutrition, pathology, physiology, processing, public health, and more. In January 2022, JDS became a gold open access journal.

Reporting checklists	Authors must upload a completed reporting checklist upon submission.
IACUC approval, animal welfare, and human subjects research	All research animal activity must be performed in compliance with federal, state, and local laws and regulations. The authors should state explicitly that institutional animal care and use (IACUC) or equivalent approval was obtained before commencement of the study. Research involving human subjects (e.g., surveys, sensory panels) must comply with all appropriate laws, regulations, and policies governing the use of human subjects in research.
Graphical abstract and highlights	Optional; instructions here and here . Upload the graphical abstract/highlights to ScholarOne Manuscripts in a separate file.
Scientific sections	Dairy Foods: Bioactivity and Human Health; Chemistry and Materials Science; Dairy Product Microbiology and Safety; Food Systems and Environment; Processing and Engineering; and Sensory Analysis. Production: Animal Nutrition; Farm Systems and Environment; Genetics and Genomics; Health, Behavior, and Well-being; Physiology.
Article types:	
Research article	Full-length research articles include systematic reviews and meta-analyses. The journal emphasizes the importance of high-quality scientific writing and clarity in presentation of the concepts and methods, and sufficient background information to allow thorough understanding by scientists in other disciplines. The results published must be replicated, either by replicating treatments within experiments or by repeating experiments. Authors should aim to keep full-length research papers to 10 published pages (about 30 double-spaced manuscript pages) or less.
Invited review	JDS publishes invited reviews in all scientific sections of the journal. Authors interested in writing a review should contact the Invited Reviews editor Kerst Stelwagen (kerst.stelwagen@scilactis.co.nz) with justification for the review. Authors should not submit a review without first receiving an invitation letter. The Invited Reviews editor may also solicit reviews on topics of interest. Invited reviews are limited to 10 published pages and are published at no charge to the authors.
Symposium review	The editor-in-chief invites selected topics from the ADSA annual meeting to be published in the journal. Symposium reviews must be prepared according to JDS Style and Form and submitted to the appropriate scientific section (not as invited reviews). These papers will undergo the same review and editing process as other papers submitted to the journal. Symposium reviews are limited to 5 published pages and are published at no charge to the authors.
Grad Student Lit Review	Graduate students may submit their literature reviews (as Grad Student Lit Review) to be evaluated by the journal for publication as review papers and for submission to the Graduate Student Literature Review Award, sponsored by the ADSA Foundation. Papers must be prepared according to JDS Style and Form, contain no more than 30 double-spaced pages and 75 references, and be submitted to the appropriate scientific section of the journal (not as invited reviews). See here for more information. Literature reviews are limited to 10 published pages and are published at no charge to the authors.
Letter to the editor	Short (300 words) letters to the editor on topics of concern to readers, including comment on publications with rebuttals from authors, may be submitted to the editor in chief or to any of the editors. Letters are published at no charge to the authors.
Perspectives	These short, invited papers are written by established and emerging thought leaders from various areas of dairy sciences. Papers are concise, evidence-based, and referenced and provide commentary and food for thought on a research area or question relevant to dairy science.
Manuscript preparation	Refer to <i>Journal of Dairy Science</i> Instructions for Authors: Style and Format for detailed instructions on style and form, statistics, nomenclature, abbreviation usage, and table and figure preparation.
Format (research articles)	Abstract; Introduction; Materials and Methods; Results; Discussion (or combined Results and Discussion; Conclusions (optional); References; Acknowledgments/Notes (funding, acknowledgments, conflict of interest).
File uploads	Manuscript and reporting checklist (required); graphical abstract and highlights (optional). Submit here: https://mc.manuscriptcentral.com/jds
Data supplements	Supplemental data files should be submitted to a third-party host and linked by URL in the manuscript.
